Hello my Name is Patrick Modesitt,

My son Connor is in the 7th grade and we have been apart of NCCS for past 8 years. To start I want to apologize as this is my first NCCS board meeting. This has been an eye opening experience and it amazing how fast time flies and again I'm a little embarrassed that this is my 1st Board meeting. Not that I have not been involved in the school . My wife Christine was president and vice president of the Education foundation
We are currently the coordinators for Ski/Snowboard club and I have helped out by coaching and volunteering for Ed foundation fundraisers and in the classrooms with teachers. So I'm not entirely absent.

That being said I have been active in our community and have served on many boards. I have even served with some of your fellow board members. I would like to take this opportunity to thank you all for what you do. I do understand you have a difficult job and I truly appreciate all of your time and hard work to make this school great.

I am here today because of the incident that occurred on DEC 2^{nd} in referencing the graffiti on the boys bathroom stating that the "school would be shot upon DEC 5^{th} " I'm sure all of you were alarmed and concerned as I was/still am concerned.

As you all are aware the school send out a message early Thursday morning about a possible threat. What was most concerning to me was I was hearing from other parent's night before that there was an incident and when I did receive notification from school, I received it in a hasty manner. My son Connor as well as 2/3 of students didn't attend classes that day. HMMMM.. What does this say!!!My wife and I discussed options and we both made a quick decision not to send Connor to school because We didn't have all the facts.

We were not informed.

We did not feel like proper action was taken by this administration. The timeline between the discovery and the notifications to LE and parents along with "Sheriffs office will provide a presence at the school at various times through out the day" did nothing to put my mind at ease. So that got me thinking.

Having been apart of many Emergency, Active Shooter training as a 1st responder /Firefighter/Paramedic at schools and public spaces along with an extensive military background in State of California with counter terrorism both within intercontinental US and abroad. I wanted to know what the policy entailed when it comes to threats, and active shooter at NCCS. I spoke to my son Connor to ask if he has ever drilled on such events. He informed me NO. This was a sobering conversation and quite frankly the real reason I'm speaking before you today.

Connor my son who I believe is a bright young man growing into young adulthood. We had a conversation about what to do in the event of active shooter at NCCS. Just saying that in referencing NCCS makes me sad and that the evils of the world are now touching my precious little boy.

I have been trained and educated to deal with such threats but my son Connor has not. This week was a sad week for me as a parent. What attracted us to this great little school was sense of protection from outside world and to always be safe. That being said I still educate my son on dangers of the world but usually on my terms. I still think and believe NCCS is a safe great school and happy to have Connor apart of it

I searched the boards policy on-line and could only find actions on threats under graffiti clause. I went to school and spoke to Mr Kutrz directly. Thank you for taking to time with all my questions. I did find the Emergency plan for NCCS and talked to Connor about it and he was **not** aware still of what to do.

I was in disbelief/shock, denial, pain, angry, depressed and now accepting and became self aware I was navigating through the 7 stages of grief.

As the days continued more information was put out both officially and unofficially with some conflicting information. I wanted to know the facts.

I was informed there was a impromptu meeting Friday morning with Mr Kurtz and lots of information good and bad was going around. This led to more unanswered questions. I was not happy with how this incident was handled. What did I expect what did I want.

My wife informed that there was a meeting being held at Good Times Pizza Tuesday for parents to gather and discuss the incident. I was told I will be attending and to get the facts. Funny how you just do as your told. At the meeting I felt it was a great opportunity for concerned parents to express there feeling and to talk in an open forum and to be heard. We as parents need to be heard and we need feel we are apart of the process with our children. Still a ton if unanswered questions and they continued.

We at the meeting found some talking points that we want to be address

- 1)What steps were taken by School/Principle for Dec 1st incident
- 2) What steps are required by policy
- 3)What steps were missed.
- 4) Need to drill for emergencies at least bi-annually
- 5) Update policy to require principle to notify LE when threat to commit violence has been made
- 6)review Emergency Procedures (Repeated 3 Short Bell Burst) students do not know what this is.

Also there was a lot of misinformation going around: Did NCCS even have a Emergency Plan and what was in it? Did NCCS have locking doors, blinds?

As I have found that yes we do have all of these State/County required safeguards when it comes to security. And an Emergency Action Plan

So I did some more research I sat down and spoke to Mt Kurtz, he answered most of my questions. I sat down with Mr Martinez Principle at Junction school. I talked with Bella Vista School via principle Mrs Armelino and her staff and had another parent talk to Milville school about their Emergency Plan. What I found is that NCCS is on par with all the other schools for the most part.

Some take aways I did see that all other schools do drill on emergencies other than just fire drills. I believe we NCCS should drill either as staff at a minimum and as a school. If an actual emergency does occur we/students and staff are prepared. I also found that all other schools get LE in from the start. They have all said it better to get them in and then make determination together from there.

Concerns:

No pictures were taken of threat LE/Staff/Parents were not notified in timely manner Only limited Staff was notified Why no drills for intruder/active shooter Who does Principle/Superintendent answer to

This needs to addressed by the Board!

I have been working with Mr Kurtz and he is currently creating or created a "Threat Discipline Reporting Protocols" that are addressing our concerns. The (TAT) Threat Assessment Team" I understand he is bringing this up to be approved by the board tonight. I will let him speak on that. He has been open and has asked for input. I feel apart of the solution I feel I am being heard. Thank you

I think that last weeks meeting at Good Times Pizza was a great forum for parents like myself to voice concerns and to be heard. Thank you Katherine Frye! For putting this together

I want to feel I have some control on what is going on when it comes these incidents. I want to feel apart of the process and be part of the solution. I do want to work in a positive manner and to get our objectives accomplished together.

Mr Kurtz and I have spoken about this I still think he should have set up a forum for parents to be heard and get answers to questions. I know you have an open door policy and have always been open. When an incident of this magnitude happens and 2/3 of school stays home a proactive meeting should have been put into motion. I think most of our concerns could have been mitigated.

Another takeaway as I did get to know what great parents we have along with the teachers for our children. The information is here and maybe it takes and incident such as this to get info out that plans are in place but they must be drilled on and enforced by the administration.

Most importantly we are here talking about a incident that didn't occur. We are not on ABC tonight news talking about how could this happen to our quiet little school. We are in a good place and I want this to be a positive process to allow parents/students/staff and administration better together.

School Description and Mission Statement (School Year 2019-20)

North Cow Creek School (NCCS) is a small, rural school of approximately 260 students in grades K-8, which was first established in 1882. Located in Palo Cedro, 9 miles east of Redding in beautiful Northern California, the campus includes a gymnasium, STEM/Innovation lab, full playground and athletic fields as well as classrooms.

NCCS has a strong focus on academics, as demonstrated by its consistently high Academic scores.

The school program is enhanced by sports, field trips, a middle school activity period, student participation in and classroom music and choir. Students receive technology education through multiple weekly visits to the Innovation Lab (I-Lab). Students in grades 1 - 8 are each assigned a chromebook for use within the classroom. Technology resources are enhanced through a 1 gigabyte fiber line.

North Cow Creek School also offers a district-run after-school and before-school day-care program. The school has been recognized as a California Distinguished School, a Governor's Fitness Challenge award winner, and has received the California Superintendent's Challenge Award i.

The vision of the staff at NCC is to build a community empowering life-long learners who pursue a promising future for themselves and our world.

Types of Services Funded (Fiscal Year 2018-19)

General funds are principally utilized to provide a qualified staff, curriculum, and facility that supports the academic and behavioral growth of all students. In addition to the core curriculum, funds are utilized to provide an athletic program for students in grades 4 - 8, STEM activities for all grade levels, technology resources that enhance the delivery of instruction as well as providing students access to relevant and real-life resources.

Supplemental funds are principally directed towards unduplicated students, including low income, foster and homeless youth, depending on grade level, are monitored, using a research based assessment, in letter naming and sounds, nonsense words, reading fluency, and comprehension, math facts and math for a minimum of two times in each school year and that students falling in the intervention areas for each assessment will be provided with appropriate services to achieve at grade level or to make progress toward closing the achievement gap. The primary assessment utilized is iReady. Curriculum-based assessments are also utilized along with state assessment data. Additional services are provided through targeted intervention within the Learning Center by a .4FTE intervention teacher, access to the online iReady program for students in grades TK-8, and the SIPPS program. A district curriculum administrator/training works with grade level teachers as we strengthen small group Tier I interventions within the classroom provided by the classroom teacher and paraprofessional assistance. Providing direct intervention services by an intervention through the learning center and the classroom teacher receives support through collaboration and resources provided by the intervention teacher.

- 3. Targeted interventions (ELA and Math) through the Response to Intervention model through small group instruction within the classroom and through the Learning Center.
- 4. A focus on enhancing school culture through team building activities, PBIS (Positive Behavior and Intervention Supports), and Peaceful Playground implementations.

Professional Development is delivered through school workshops, conferences, individual support by a district curriculum administrator, online courses, and targeted print resources. Staff are supported in the implementation of key learning through peer support, administrative observation, and participation in county-level workshops.
